The Union of Mediterranean Confederations of Enterprises (BUSINESSMED) is a regional organization which gathers 24 Confederations of Employers' Organizations from 18 countries of the Northern and Southern shore of the Mediterranean. Created in 2002, BUSINESSMED is the main representative of the private sector of the Euromed region and a privileged platform for multilateral cooperation for the benefit of the employers' confederations and a network of more than 1200,000 public and private affiliated companies, by promoting foreign direct investments and socio-economic integration in the region.

As one of the main Business Support Organization dedicated to intergovernmental cooperation in the Mediterranean, BUSINESSMED seeks multiple objectives and missions such as:

- ncreasing exchanges between the European Union and the MENA Countries.
- Drive of lobbying activities aimed at a wider participation of the private sector to the actions carried out by governmental authorities.
- Animating the main think-tank around the empowerment of women and the actors of civil society and the Euro-Mediterranean Social Partners.
- Undertaking partnership actions between business communities of the region through the participation in institutional and networking events and the high-level working groups.
- Enhancing technological transfer and know-how towards the Southern Mediterranean countries through vocational training sessions, mentoring, professional coaching in favour of business support organizations and young entrepreneurs

In addition to integrating these principles into our day-to-day operations and culture, we have been making sure that the human rights principles, the environment, fighting corruption and labour standards are respected and tackled during the implementation of our conducted projects, namely:



The Pilot Project for the Promotion of Social Dialogue in the Southern Mediterranean Neighborhood- SOLiD was a three-year project (2016-2018) co-funded by the European Union. It's a pioneer programme whose ultimate goal is to promote a dynamic, inclusive and reinforced social dialogue via the development of the capacity of Trade Unions and their homologues of Employers' Associations and civil society organizations and the promotion of a civic and multipartite dialogue between the social partners in three targeted countries: Tunisia, Jordan and Morocco.

A second phase of the Project started on December 2020 for a period of 4 years.

Algeria, Lebanon and Palestine were added to the targeted countries.



Enhancing Business Support Organisations and Business Networks in the Southern Neighbourhood- EBSOMED is project co-financed by the European Union and coordinated by BUSINESSMED. More than 30 organisations from 26 countries are also affiliated to the project. The ultimate goal of this 4-year project (2018-2022) is to promote the Mediterranean Business Ecosystem by boosting investment and job creation in the region with a view to economic growth. This will be done through the strengthening of the capacity building of Business Support Organisations-BSOs in the Southern Neighbourhood Countries. More specifically, EBSOMED intends to increase the capacity management of BSOs in the Euro-Med region by improving the services offered to SMEs.









The INVESTMED project aims at addressing both economic and environmental challenges in terms of competitiveness, sustainability, internationalization and capacity to innovate, supporting new, sustainable business opportunities for young people and women in three

Mediterranean Partner Countries: Egypt, Lebanon and Tunisia. The project will support the development of new, sustainable entrepreneurship and business initiatives, by creating a backing environment and facilitating access to new markets with the final goal of generating new economic opportunities and jobs. INVESTMED benefits Mediterranean Business Support Organisations (BSOs) and their network of enterprises. They will benefit from training, coaching and sub-granting to grow and to become sustainable. Markets and clusters of companies aiming to introduce sustainable and creative services in their value chain, can also benefit from this project.



HOMERe is an intra-Mediterranean Internship Mobility scheme offering companies in search of new business perspectives a unique opportunity for sourcing young talents from the Euro-Mediterranean region to become their interns. HOMERe improves the crosscutting skills and increases the employability of Mediterranean high-profile students. The project aims to tackle youth unemployment and underemployment and help those taking part in the project to secure a graduate position that is relevant to their qualifications and is in their own country. Through its extended network of high-level academic institutions on both sides of the Mediterranean, HOMERe aims to attract transnational private companies that operate in the Mediterranean region and are searching for brilliant profiles. The programme provides help in the identification; preparation and mentoring of appropriately qualified students.

CREACT MED

The overall objective of CREACT4MED is to enhance the role of culture and creativity as a vector for employment and resilience in eight SNCs through untapping the potential of the cultural and creative industry (CCI) to create economic value, enhance growth, and foster social inclusion.

Among the missions of this project is to boost the cultural and creative industry (CCI) in the Southern Neighbourhood of the European Union attracting investment and creating jobs and Support CCI business models led by youth and women entrepreneurs giving them access to a training & coaching program and access to funding for the development of their projects.

The academy was an opportunity to reinforce Business Organizations' strategy and added value through a practical and strategic framework.

EBSOMED ROADSHOW MED BUSINESS DAY: TOWARDS AN INCREASE IN FOREIGN DIRECT INVESTMENT IN ALGERIA

January 10th 2019, Algiers





In the framework of the EBSOMED project, BUSINESSMED organized on January 10th, 2019 in Algiers the MED BUSINESS DAY Roadshow, in partnership with CONFINDUSTRIA (Italy) and CGEA (Algeria).

This event aims to provide the stakeholders of the Euro-Mediterranean entrepreneurial ecosystem with the opportunity to identify new partners and start new business relationships. The event brought together more than 370 Mediterranean economic actors, including a strong delegation of 40 Italian companies After the opening session, parallel sessions were hosted by Euro-Mediterranean experts on Digital sector, Renewable Energies, Building and Public Works and Automotive and Mechanical industry.

EBSOMED BUSINESS MATCHMAKING FORUM TOWARDS AN INNOVATIVE PARADIGM FOR SUSTAINABLE DEVELOPMENT ACROSS THE MEDITERRANEAN

April 15th -16th 2019. Cairo







In the framework of the EBSOMED project, the Federation of Egyptian Industries (FEI) and BUSINESSMED organised a Business Matchmaking Forum under the theme "Towards an Innovative Paradigm for Sustainable Development across the Mediterranean". The 2-day event was held on April, 15th and 16th, 2019 in Egypt, Cairo. Overall, the event gathered more than 950 Economic operators and stakeholders from the Euro-Mediterranean region. The Forum aimed at improving the attractiveness of Mediterranean business ecosystems by consolidating business networks and providing interactions and synergies between all actors coming from the two shores of the Mediterranean.

The first panel focused on the Impact of supporting vocational training and education for economic growth and was dedicated to key lessons on developing 'dual vocational training' to support the labor market insertion of women and youth in disadvantaged areas. The second panel focused on the promotion of business partnerships synergies in the Euro-Mediterranean Region through networking apportunities and project cross-sectorial cooperation.

TRAINING WORKSHOP "SUCCESSFULLY MANAGE, REPORT AND EVALUATE AN EU FUNDED PROJECT"

May 6th -8th 2019, Tunis

June 21th 2019, Marseille



BUILDING BACK RESILIENCE CYCLE

Connecting Business Initiatives Response to COVID19-: Transforming the Private Sector engagement through SDGs

October 22''', 2020, Online





With the evolving situation of the 2020 humanitarian crisis, BUSINESSMED noticed that BSOs are grappling with how to ensure their business continuity, to continue serving their members and to better comply with the new working conditions. Taking that and the travel restrictions into consideration, BUSINESSMED redesigned its academies planned in the framework of the EBSOMED project.

To address these challenges, the academies were redesigned to debate the agility and resilience of the BSOs to ensure business continuity in different area of work. To do so, BUSINESSMED conceived a cycle of webinars and mobilized international organizations with regional expertise and conducted their recovery plan to give share their knowledge and formulate recommendations to respond to the Covid-19 crisis. The cycle was called "Building back resilience: the role of Employers' and Business Association in shaping the new normal" and was divided into 4 online events.

The webinar "Connecting business initiatives response to COVID-19: transforming the private sector engagement through SDGs" was held on October 22nd, 2020 and was an opportunity to explore how COVID-19 has disrupted businesses across the Mediterranean and focused on the way organisations can connect their sustainable initiatives to respond to the crisis. Recommendations were formulated focusing on the role of the involved institutions in addressing the unfamiliar challenges that have come with the pandemic with a focus on the private sector's response to crisis in a way that aligns with the SDGs.

Correcting Labour Market Imbalances and Promoting Employment and Employability through Social Dialogue between Employers' and Trade Union Organisations

November16^{`''}, 2020, Online







The debate webinar "Correcting Labour Market Imbalances and Promoting Employment and Employability through Social Dialogue between Employers' and Trade Union Organisations" was held on November 16th, 2020 and fed into renewed cooperation amongst social partners, leading to tangible improvements for the Mediterranean businesses, workers, and citizens alike. It was an opportunity to explore the important role that social dialogue plays to tackle widespread unemployment in the Mediterranean from social partners perspectives.

The webinar gave insights into the way Social Dialogue can support Employers and Trade unions develop and implement gender-responsive employment and labour market policies in line with the 2030 Agenda for Sustainable Development. It also highlighted the employment policies needed to tackle widespread unemployment and underemployment from Trade unions and Employers perspectives. The intervention of the ILO representative gave the opportunity to explore the ways social dialogue was able, on some of their initiatives, to address employment, employability and decent work-related issues.

THE UPSKILLING IMPERATIVE: VOCATIONAL TRAINING AND THE NEW OFFER OF BSOS' SERVICES.

December 7th 2020. Online





The emergence of new business models and alternative forms of work organisation sped up changes in the skills required by the labour market. These changes have been intensified by the challenges imposed by the Covid-19 with further evidence in the Southern Neighbourhood region.

For this reason, BUSINESSMED focused on this particular subject for the third webinar and organized on December 7th, 2020 the event "The upskilling imperative: vocational training and the new offer of BSOs' services". Through different interventions and testimonials, the webinar focused on how SMEs should reconsider the skills to remain competitive. Formulated recommendations on providing access to additional up-skilling opportunities for economic operators across the Mediterranean were expressed by the panellists.

The debates highlighted the way covid19 accentuated the need of digital skills in many aspects for business continuity and how gaining new skills is key for sustainable competitiveness and resilience for Businesses as they need workers with the right skills to master the challenges defined by the current transition.

THE SANITARIAN CRISIS AS AN ACCELERATOR OF THE DIGITALISATION PATH OF THE MEDITERRANEAN BUSINESS ECOSYSTEM

February 25th 2021, Online





The event reviewed several aspects related to the digital transformation of the region including the changes planned by Business Support Organizations in their economic and structural models, the emergence of cross-border e-commerce but also an assessment of the use of technology by women entrepreneurs in the Mediterranean region.

The Webinar focused on providing concrete solutions to meet the challenges of the Post-COVID19 economic recovery for SMEs to access new markets. The debate emphasized the way internationalisation benefited SMEs in industrialised countries focusing on the innovative platforms and opportunities offered for cross-border e-commerce.

As a success story, the Business Country Desk developed by BUSINESSMED showed the interconnectivity opportunities offered to SMEs across the Mediterranean. Through its innovative platform (BCD), BUSINESSMED is targeting the increase of regional cooperation and stability. The platform is facilitating business-to-business trade online and cooperation within the region and on the border rules-based multilateral systems.

In the framework of the EBSOMED project, BUSINESSMED, in cooperation with MDF Brussels, organised on 29 & 30 June and 2 & 3 July 2020, an Online Workshop on Support to Project Development "The design of a solid EU Project Proposal: The Logical Framework approach"

About 20 participants from different BUSINESSMED member organisations took part in this 4-day training where each session was an opportunity to deepen the aspects and steps of designing a project proposal.

The participants enriched the exchanges by sharing their personal experiences and the concrete cases they worked on that are specific to their environment and type of organization. The training ended with a virtual ceremony for the distribution of certificates of participation.

WORKING MEETING FOR THE COMMITTEE "GENDER MAINSTREAMING AND WOMEN AND YOUTH EMPOWERMENT

July 20[™] 2020,Tunis



The meeting resulted in reviewing the first deliverable of the instrument giving emphasis to the necessity to include some national and regional priorities by incorporating a gender perspective across different sectors in the target countries.

The action plan has been defined as well as the main topics of the survey and the methodological approach; that includes the definition of different practical tools that can be used to help integrate a gender perspective into all stages of policymaking and strategic planning of the committee's work.

BUSINESSMED ONLINE BSO MANAGEMENT ACADEMY ON "DIGITALISATION OF SERVICES"

12th October -17th December 2020, Online







In the framework of BUSINESSMED's strategy for business continuity of its members, a cycle of training webinars was organized, focusing mainly on how organizations can adapt their business models to take full advantage of the digital transformation.

The aim was to train participating organizations on how to develop an effective and reliable digital strategy and gain guidance on integrating digital throughout all the steps of the business chain.

BUSINESSMED PRESENTS THE FIRST RESULTS OF ITS THEMATIC COMMITTEE ON "EDUCATION AND R&D ON ENERGY TECHNOLOGIES"

14th December 2020, Online





BUSINESSMED presented on December 14, 2020, in a webinar, the first results of the study conducted by its Thematic Commission "Education and R&D on Energy Technologies" established under the EBSOMED project.

Employers have a key role in addressing the energy transition in the Mediterranean and the green recovery by tackling new trends and technologies affecting the production of energy. Many concepts emerged and R&D on Energy Technologies becomes the main focus of the Mediterranean Countries.

This online meeting, which brought together members of the Thematic Commission and experts in renewable energy, was an opportunity to clarify the objectives of the Commission and the methodology adopted to produce its regional thematic paper. It was also the occasion to present its first Factsheet on "Education and R&D in Energy Technologies" with the aim to inform employers' organizations and SMEs affiliated to the energy sector in partner countries (Egypt, Jordan, Malta, Tunisia), with special emphasis on their strategies, action plans and achievements in renewable energy.

BUSINESSMED PRESENTS THE FIRST RESULTS OF ITS THEMATIC COMMITTEE ON "VOCATIONAL TRAINING AND SKILLS DEVELOPMENT"

15th December 2020, Online





Within the framework of the Thematic Committee "Vocational Training and Skills Development" set up under the project EBSOMED, BUSINESSMED organized on December 15, 2020 a Webinar aiming at presenting the strategic orientations and the first conclusions and publications of the committee that intended to answer the priorities of the Technical and Vocational Education and Training (TVET) sector as defined by the European Union.

BUSINESSMED, with the aim to address the opportunities and suggest a list of recommendations and scenarios to help address the TVET sector challenges, created the Thematic Committee on "Skills Development and Vocational Training". This committee gathered Employers' Organisations from the EuroMed Region, believing that today's economy requires advanced, flexible and fungible skills and that VET can boost organizational performance, competitiveness, research and innovation which is a central aspect of successful employment and social policy.



Specific business incubation services will be established for sustainable start-ups while relevant public authorities will benefit from capacity building and exchange of best practices to facilitate access and protect the intellectual property right for MSMEs.

The Euro-Mediterranean Economists Association (EMEA) organized a meeting under CREACT4MED (CReative Entrepreneurs ACTing FOR the future MEDiterranean) project on Monday 27 July 2020. This meeting is part of the CREACT4MED project Mapping activity, which aims to explore the CCI ecosystems of Southern Neighborhood Countries.

The CREACT4MED project, launched in March 2020 and led by EMEA with 4 partners [IEMED (Spain), BUSINESSMED (Tunisia), IED (Greece) and FEPS (Egypt)] aims to enhance the role of culture as a vector for employment and resilience in Southern Neighbourhood Countries (SNCs).

This virtual meeting brings together experts, researchers and other stakeholders to exchange views and experiences on the CCI ecosystem in the region.

During the meeting, the call for the Technical Expert Group on CCI and entrepreneurship in the Mediterranean is launched. The final composition will be announced in September 2020.
